Post and in person

Withdrawing money

Your church/entity can decide the level of authority your authorised signatories have.

Depending on how you set up your investment, you can withdraw money by phone, email or postal/fax request.

- Phone or email your request to our office by 3pm and we will transfer the funds to your linked account, the same day*. Phone transactions are password protected and email addresses are verified.
- Post or fax a withdrawal form. Signatures will be verified to the authorised signatory instructions.

#Linked accounts

We can link your At Call investment to an appropriate existing savings or cheque bank account.

Terms and conditions

- This investment is not available to individuals.
- *A Direct Debit Request (DDR) form must be completed before CDF can transfer funds from an external bank account to CDF (including EASY SAVE).
- Transfer from your CDF At Call to your bank account, where no Direct Debit Request Form is held, we require an initial signed written confirmation on letterhead stating all necessary bank account details.
- Requests for funds transfers received after 3pm will occur the following business day.
